# FYI: Florida is a closed primary state

The political signs are beginning to emerge throughout Indian River County. The 2024 Primary Election is quickly approaching and voters need to be prepared.

If you are new to the state of Florida, you may not be aware that Florida is a closed primary state. What does that mean?

Closed partisan primary elections are elections in which only voters affiliated with the political party holding the primary are eligible to participate. Voters receive a ballot listing only those candidates running for office for the nomination of the political party with which the voters are affiliated.

Typically, that would be either one of the two major political parties - Republicans and Democrats - if they have candidates for an office on the primary election ballot.

In a primary election, all registered voters can vote for Universal Primary Contests, nonpartisan races, and referendum questions regardless of which major or minor political party they are registered or even if they are registered without a specific party affiliation.

A **Universal Primary Contest** is a race where all the candidates for an office have the same party affiliation and the winner of the primary election will not face any opposition in the general election.

For the Aug. 20 primary election, the following races are Universal Primary Contests: the Tax Collector and County Commissioner District 1 and District 3.

In a primary election, all voters have the opportunity to vote for school board candidates since school board is a **non-partisan race**. Non-partisan candidates are prohibited from qualifying or campaigning based on party affiliation.

School Board elections for District 3 and District 5 will appear on the primary election ballot. Since only two candidates have qualified for each district, the primary election will determine the winner.

At a general election, all registered voters receive the same ballot and may vote for any candidate or question on the ballot.

If there are write-in candidates who have qualified for a particular office, a space will be left on the general election ballot where their name can be written.

# Assist To Vote Tour

Visits made to independent- and assisted-living facilities in April, May

Indian River County Supervisor of Elections Leslie Swan and Vote By Mail Coordinator Daisy Zamora, along with additional staff, took to the road in late April and early May for the Assist To Vote Tour.

The Elections Office wanted to make sure residents in independent- and assisted-living facilities had their voter information up to date and were prepared for the 2024 elections.

## Assist To Vote Tour

Pelican Landing in Sebastian, and Sonata Independent Living and Indian River Estates in Vero Beach were among the locations visited by the elections staff.

Residents at each location were assisted with registering to vote, updating their voter record and requesting a Vote-By-Mail Ballot for the 2024 elections.

New residents to Indian River County were given the opportunity to register to vote.

Existing voters were able to make address updates or changes to their party affiliation, if desired, schedule ballots by mail or update their signatures.

When voting by mail, a voter's signature on file is used to verify the signature on the voter's certificate return envelope. Voter registration applications were available for signature updates.

## Vote By Mail

Voting by mail refers to voting a ballot received by mail or picked up by or for a voter instead of going to the polls. Ballots are mailed approximately 40 days prior to Election Day.

The deadline to request a ballot be mailed is 5 p.m. Aug. 8 for the Aug. 20 Primary Election and 5 p.m. Oct. 24 for the Nov. 5 General Election.

**Closed Primary State**

Florida is a closed primary state. Only voters who are registered members of political parties may vote for respective party candidates or nominees for an office in a primary election. Voters can change their party affiliation up to 29 days before a primary election. The deadline is July 22 for the Aug. 20 Primary Election.

**Supervised Voting**

Supervised voting was explained to the residents. It is:

- Available to voters residing in any assisted living or nursing home facility if requested by at least five registered voters within the facility.

- The Elections Office will deliver the ballots and supervise the voting on the scheduled date and time.
- Supervised voting consists of teams of two election staff members of different party affiliations, who are on site to offer assistance.
- The voter has the option to keep the ballot and seek help by someone other than the supervised voting team.
- Deadlines to request Supervised Voting: July 23 for the Aug. 20 Primary Election and Oct. 8 for the Nov. 5 General Election

The Elections Office facilitates voting through DoubleClick Democracy, an online ballot that allows students in grades K-8 to vote for their favorite book.

The ballot, which is programmed by the Elections Office, uses the book title and a picture of the book cover to allow students to identify their favorite book. Students receive an “I Voted” sticker, pencil/pen, and a certificate for their participation in the election. The results are emailed to each school.

The SSYRA/FLA programs are a great way to encourage reading and introduce students to the electoral process. It is never too early to educate students on the importance of voting.

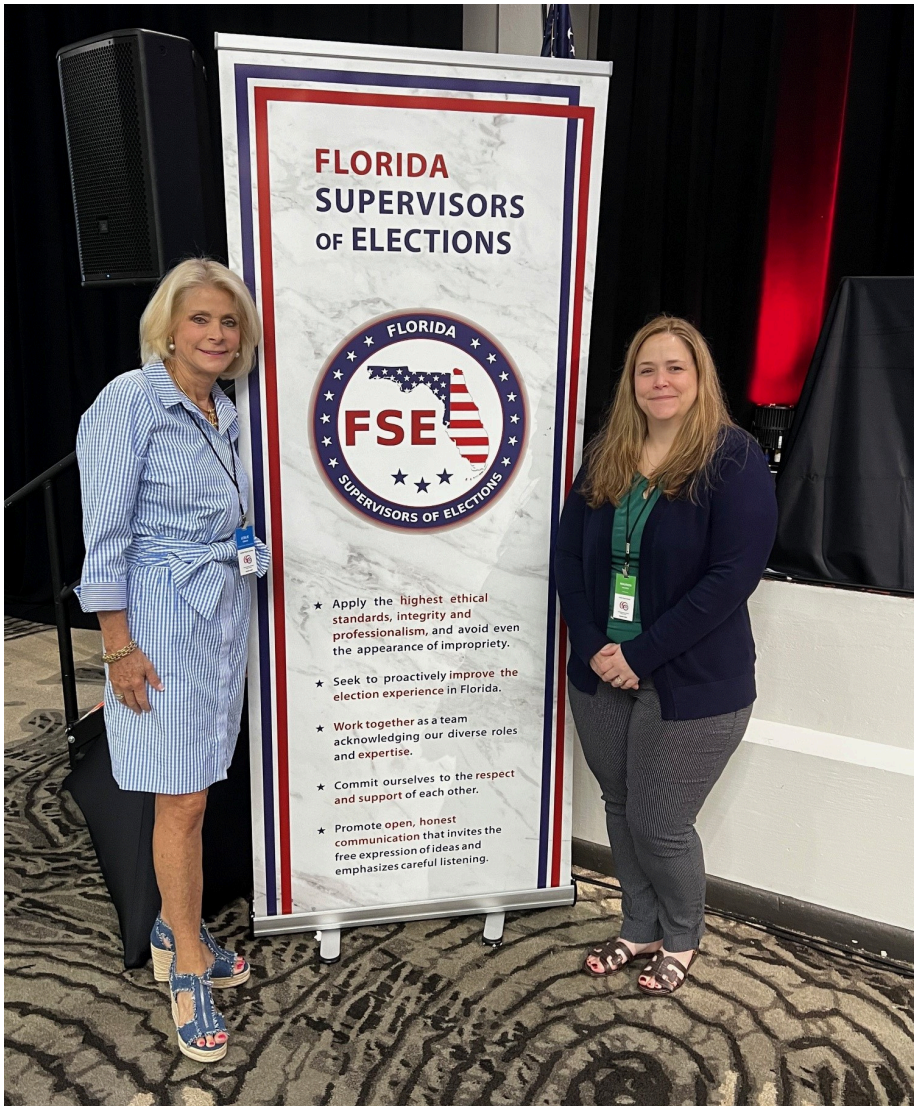

## Petition process closed for 2024

That's a wrap for all State and Local Candidate Petition verification for 2024.

The Indian River County Supervisor of Elections office had 14 County candidates and 2 Special District candidates qualify by petition for the 2024 Election Cycle. County candidates were required to receive 1,194 accepted valid petitions while Special District candidates needed 25 in order to qualify by petition. This number is based on one percent (1%) of active voters at book closing for the 2022 General Election.

After many hours of petition verification, the Indian River County Supervisor of Elections staff processed 25,853 candidate petitions for the 2024 Election Cycle.

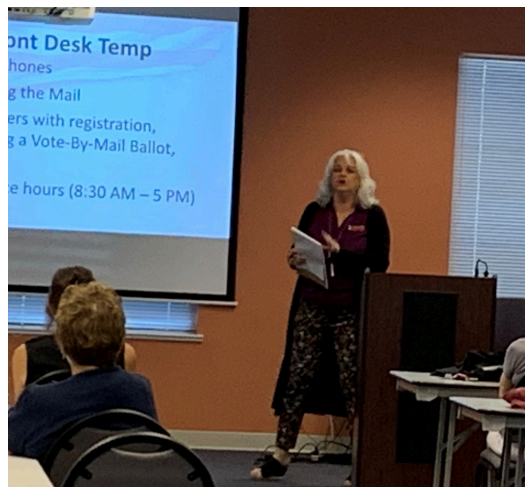
## 120 attend Election Worker orientation classes in May

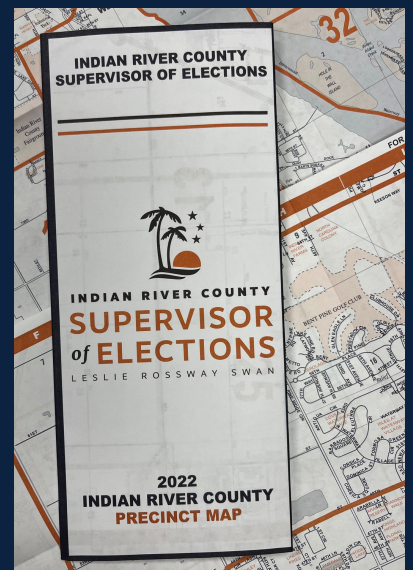
Hot  off the Press!

# Remembering Kay Clem: 1953 - 2024

## 'We will miss you dear friend'

It is with heavy hearts the team at the Supervisor of Elections office mourns the death of former Supervisor of Elections Kay Clem, who died in early June.

Clem dutifully served the voters of Indian River County for 14 years.

"Her quick wit and infectious laugh were ever-present at the Elections Office," said Supervisor of Elections Leslie Swan, who started working for Clem in 2004 and succeeded her as supervisor in 2011. "We will miss you dear friend."

Born Debra "Kay" Scott on July 19, 1953, she carved her own path by entering the political workforce in her early 20s, where her natural intelligence, work ethic, and charisma moved her swiftly up the corporate ladder in an era where few women were able. She worked in the Office of the Senate President in Tallahassee for a number of years and subsequently served as Executive Director of the State Republican Party of Florida, becoming a key player in bringing the Republican Party into new political prominence in the State of Florida.

She married her devoted husband, attorney Chester Clem, and moved to his hometown of Vero Beach following their wedding in 1989.

Kay continued to pursue her interest in politics and service in Vero Beach. When the office of Supervisor of Elections for Indian River County came open in 1996, she was elected to the position, where she dutifully served the community for approximately 14 years.

Kay's passion for the job was evident, leaving only after suffering the debilitating onset of her chronic neurological disability. During her tenure, she received many accolades for her service and hard work and was particularly instrumental in guiding Indian River through a smooth election during the otherwise contentious 2000 presidential election of Bush v. Gore.

Kay, born in Hattiesburg, Miss., moved with her mother, father, and two brothers to Chattahoochee, Fla., a small rural town on the Florida panhandle that she affectionately called "the Hooch," where she grew up and attended school. Upon graduation from Chattahoochee High School, she completed several semesters at Florida State University in Tallahassee, and remained a proud Seminole fan throughout her life.

Shortly after moving to Vero Beach, Kay and Chester were blessed with the birth of twin daughters, Mary Katherine and Elizabeth, in 1992.

Kay had great affection for Chester's three sons by his prior marriage and worked hard to ensure that all family members

maintained a close and loving relationship.

She always expressed pride in her family and worked tirelessly to keep family love and friendship in place.

In addition to her busy professional life, Kay so enjoyed the fulfillment that motherhood brought and avidly served on the PTA and attended as many school, sports, social, and other extracurricular activities as possible. She was exceptionally proud of both her daughters and their accomplishments.

Kay had many other admirable qualities. She was a practicing Episcopalian all her life. She loved to read, but more than anything, enjoyed making other people laugh, a skill that she was especially adept at employing. Kay will be remembered by all her friends and family for her wonderful and witty sense of humor and infectious laugh, which she steadfastly maintained throughout her years-long battles with her chronic disability and End-Stage Renal Disease.

She leaves behind her loving husband, Chester; daughters, Mary Kate and Liz (TJ); step-sons, Zander (Carmen), Jeff, and Chester (Stacy); and step-grandchildren, Cristina, Isabella, Alexander, and Emma.

The family had a private memorial in her honor.

# Swan celebrates 20-year milestone

2024 marks 20 years Leslie Rossway Swan has graced the halls of the Indian River County Supervisor of Elections office.

She was hired as Voter Outreach Coordinator in 2004 by former Supervisor Kay Clem, who promoted her to Assistant Supervisor of Elections and Candidate Coordinator in 2008.

Swan stepped into the job of Supervisor of Elections on March 7, 2011, when she was appointed to the post by Gov. Rick Scott. In 2012, she was elected to serve a four-year term. She ran unopposed in 2016, 2020 and again this year.



Supervisor Swan is a member of the Florida Supervisor of Elections (FSE) and the Election Center National Association of Elected Officials.

She has been honored as a Certified Elections Registration Administrator and Florida Certified Elections Professional.
